After considering the Request and the representations made therein, the Court finds that the Request has merit and should be granted. It is therefore, hereby


**ORDERED** that the Request is granted in full and in all respects; and it is further

**ORDERED** that the hearing on the Motion, as it relates to the Order Pursuant to Bankruptcy Rule 3003(c) (I) Establishing a Bar Date for Filing Certain Proofs of Claim; (II) Establishing Ramifications for Failure to Comply Therewith; (III) Approving Proof of Claim Form and Consolidated Notice of (A) Case Commencement, (B) Bar Date, and (C) Meeting of Creditors Under Section 341(a) of the Bankruptcy Code; and (IV) Approving Notice and Publication Procedures, entered August 21, 2003 is set for October 8, 2003 at 10:30 a.m.; and it is further

**ORDERED** that the balance of relief requested in the Motion shall be heard on October 29, 2003, at 10:30 a.m.; and it is further

**ORDERED** that the Debtors shall serve immediately a copy of this Order on all parties upon whom the Debtors served the Motion.
