**DEBTORS' MOTION PURSUANT TO 11 U.S.C. § 366 FOR AN ORDER  
DETERMINING THAT THE DEBTORS ARE ADMINISTRATIVELY SOLVENT**

TO THE HONORABLE UNITED STATES BANKRUPTCY JUDGE:

Mirant Corporation ("Mirant") and its affiliated debtors (collectively, the "Debtors"), Debtors and Debtors-In-Possession, file this Motion Pursuant to 11 U.S.C. § 366 for an Order Determining that the Debtors are Administratively Solvent (the "Motion"). The Debtors present this Motion and respectfully represent the following:

**JURISDICTION AND VENUE**

1. This Court has jurisdiction over the subject matter of this Motion pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A), and (O). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

## **PROCEDURAL BACKGROUND**

2. The Cases. On July 14 and 15, 2003 (the “Petition Date”), each of the Debtors filed a voluntary petition in this Court for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101, *et seq.* (as amended, the “Bankruptcy Code”). The Debtors continue to manage and operate their businesses as debtors-in-possession pursuant to sections 1107 and 1108 of the Bankruptcy Code.

3. The Creditors’ Committee. No creditors’ committee has yet been appointed in these cases by the United States Trustee. No trustee or examiner has been requested or appointed in any of the Debtors’ chapter 11 cases.

## **RELIEF REQUESTED AND BASIS THEREFOR**

4. On July 15, 2003, the Debtors filed their Amended Motion for an Order Pursuant to 11 U.S.C. § 366(b): (A) Prohibiting Utility Companies from Altering, Refusing or Discontinuing Services to the Debtors; (B) Determining that Adequate Assurance has been Provided; and (C) Establishing Procedures for Requests for Additional Services (the “Utility Motion”) wherein the Debtors sought a procedure for dealing with Utility Companies (as such term is defined in the Utility Motion) post-petition. In connection with the Utility Motion, the Debtors now file this Motion for a determination that the Debtors are administratively solvent and, consequently, that the Utility Companies are adequately assured of future payment as contemplated in section 366(b).

5. A list identifying the utility companies utilized by the Debtors in their business operations and management of their properties is attached to the Utility Motion as Exhibit “A.” (Such utility companies together with any utility companies inadvertently excluded from Exhibit “A” attached to the Utility Motion are defined as the “Utility Companies.”) The Utility

Companies provide to the Debtors a wide range of utility services (the “Utility Services”) including electricity, telephone, gas, oil, coal, pipeline, rail and transmission services.

6. Historically, the Debtors have paid all amounts owed to the Utility Companies in full and on time. To the best of the Debtors knowledge, the Debtors are current with respect to their undisputed utility invoices, excluding payment interruptions that may have been caused by the commencement of these chapter 11 proceedings. It is essential that the Utility Services continue uninterrupted. If the Utility Companies are permitted to terminate Utility Services, the Debtors’ operations, including its generating plants, will be impaired and may be forced to shut down. The latter event would have devastating consequences for the Debtors’ operations, jeopardizing the Debtors’ ability to reorganize and exposing their employees to the risk of lay-offs. Moreover, because the Debtors are a major supplier of energy services nationwide, a disruption in the Utility Services could present significant health and safety risks to the public at large and could conceivably leave millions of the Debtors’ customers without electric power.

7. Section 366(b) of the Bankruptcy Code provides that a “utility may alter, refuse, or discontinue service if . . . the debtor, within 20 days after the date of the order for relief, [does not furnish] adequate assurance of payment, in the form of a deposit or other security, for services after such date.” The Debtors believe they have provided the Utility Companies with such adequate assurance of payment by way of “other security” in the form of the Debtors’ administrative solvency and the offer of an administrative expense claim for postpetition invoices.

8. As this Court has previously opined, where the Debtor is shown to be administratively solvent, the reserve of an administrative expense priority for utilities constitutes adequate assurance of payment as contemplated in section 366(b) of the Bankruptcy Code. *See*

Corrected Preliminary Memorandum Order Pursuant to 11 U.S.C. § 366, *In re Express One International, Inc.*, Case No. 02-41981-DML-11, United States Bankruptcy Court for the Northern District of Texas, Fort Worth Division (Lynn), March 19, 2002 (the “*Express One Order*”). Other courts agree that a debtor’s financial resources are important in determining adequate assurance. *See, e.g., In re Adelpia Business Solutions, Inc.*, 280 B.R. 63, 83 (Bankr. S.D.N.Y. 2002).

9. The Debtors are administratively solvent. As set forth in the Affidavit of John W. Ragan in Support of Certain First Day Motions (the “Ragan Affidavit”), the Debtors have in excess of \$733 million of unencumbered cash. Additionally, the Debtors have approximately \$17 billion in unencumbered property, plant and equipment (the “PP&E”) and other unencumbered assets. Importantly, the Debtors have no material secured debt. The Debtors generate millions of dollars of unencumbered working capital daily, and anticipate generating sufficient cash postpetition to meet all working capital needs, including postpetition utility costs.

10. Because the Debtors are administratively solvent, the offer of an administrative expense claim to the Utility Companies constitutes “adequate assurance of payment” in the form of “other security” as contemplated in section 366(b). “[A] debtor or trustee provides ‘other security’ if the utility is assured of payment of postpetition services.” *See Express One Order*. Accordingly, because the Utility Companies have been assured of payment for postpetition services by virtue of the Debtors’ administrative solvency, an offer of an administrative expense claim for postpetition services constitutes adequate assurance of payment pursuant to section 366(b).

### **EXPEDITED CONSIDERATION**

11. Contemporaneous with the filing of this Motion, the Debtors are filing a motion for expedited consideration. Because the 20-day grace period set forth in section 366(b) will expire before the regular 20-day notice period on this Motion would run, the Debtors assert that expedited consideration of this Motion is necessary in order to effect finality of the issues relating to the Utility Companies in advance of the expiration of the section 366(b) grace period.

### **NOTICE**

12. As set forth in more detail on the Certificate of Service and service lists attached hereto, notice of this Motion has been provided to the Office of the United States Trustee for the Northern District of Texas, the holders of the fifty (50) largest unsecured claims against the Debtors on a consolidated basis, certain governmental entities, certain counsel and parties-in-interest, and the Utility Companies. Under the circumstances, the Debtors submit that no other or further notice need be provided.

### **CONCLUSION**

WHEREFORE, the Debtors respectfully request that the Court enter an order (i) determining that the Debtors are administratively solvent; (ii) determining that the Utility Companies are adequately assured of payment by the offer of an administrative claim; (iii) granting the relief requested in the Utility Motion; and (iv) granting to the Debtors such other and further relief to which the Debtors may be justly entitled.

**ORDER DETERMINING THAT THE  
DEBTORS ARE ADMINISTRATIVELY SOLVENT**

Came before the Court for consideration the Debtors’ Motion Pursuant to 11 U.S.C. § 366 for Order Determining that the Debtors are Administratively Solvent (the “Motion”). Notice of the Motion was appropriate and no other, further notices need be provided. Upon consideration of the Motion, the representations of counsel, and upon consideration of the Affidavit of John W. Ragan in Support of First Day Motions and other evidence presented at the hearing, the Court finds that the Debtors’ estates are administratively solvent and that the Motion has merit and should be granted. It is therefore, hereby

**ORDERED** that the Motion is granted in full and in all respects;

**ORDERED** that the Debtors are administratively solvent and that such administrative solvency is sufficient evidence to support a finding that the Utility Companies, as such term is defined in the Amended Motion for an Order Pursuant to 11 U.S.C. § 366(b): (A) Prohibiting Utility Companies from Altering, Refusing or Discontinuing Services to the Debtors; (B) Determining that Adequate Assurance has been Provided; and (C) Establishing Procedures for Requests for Additional Services (the “Utility Motion”), are adequately assured of future payment by the offer of an administrative expense claim; and it is further

**ORDERED** that the Debtors' Utility Companies listed on Exhibit "A" attached hereto, and to the Utility Motion, are prohibited from altering, refusing or discontinuing services to the Debtors; and it is further

**ORDERED** that this Order shall apply to all Utility Companies served with this Order with regard to the Debtors regardless of whether such Utility Company is listed on Exhibit "A" attached hereto and to the Utility Motion; and it is further

**ORDERED** that nothing in this Order, the Motion, or the Utility Motion shall be deemed to constitute an assumption of any executory contract under section 365 of the Bankruptcy Code; and it is further

**ORDERED** that the Court shall retain jurisdiction over the Debtors and the Utility Companies with respect to any matter, claims, rights, or disputes arising from or related to the Motion, the Utility Motion or the implementation of this Order.
